Purpose

Terms

This Agreement shall commence by both the Parties and remain valid for a period of five years from the date of signature, with the understanding that it may be modified by written mutual consent of both the parties. The agreement may be extended by mutual consent of the two parties after the five-year period, and it must be renewed in writing.



INTERACTION ACTIVITIES**

PREAMBLE

This understanding is the outcome of the objectives arrived at in the strategic plan envisaged by A.P.C. Mahalaxmi College, Thoothukudi. TERMS OF REFERENCE

A.P.C. Mahalaxmi College, Thoothukudi herein after called the A.P.C.M.C and the DCW Ltd., Sahapuram, herein after called the DCW Ltd., will arrange and offer training programmes in the areas identified by both DCW Ltd., and College to the members of the DCW Ltd., faculty and students of A.P.C.M.C and other public and provide other assistance and will enter into a MEMORANDUM OF UNDERSTANDING signed by Thiru. R. Jayakumar, Executive Vice-President (Works) of DCW Ltd., and Thiru. A.P.C.V. 




